Health Protocols for Arrival to Sri Lanka

Step 01 – Confirm your Arrival and Departure dates with valid flight schedule.

Step 02 – Send your confirmed flight schedule, vaccination status and passport copies to Lotus Villa.

Step 03 – Apply VISA via <http://eta.gov.lk/slvisa/>. Once you done the relevant VISA payment, you will receive ETA reference number. Kindly send received ETA reference number to Lotus Villa in order to confirm your VISA for entry purpose to Sri Lanka. All VISAS must be applied online.

Step 04 – Obtain official booking confirmation and stay invoice, PCR & Insurance coverage invoice from Lotus Villa. Please note that PCR tests and covid 19 coverage will be arranged by Lotus Villa.

- Covid 19 local Insurance coverage charge – **Euro 11.00 per person**

PCR Tests – Below PCR tests are mandatory based on Sri Lankan health guidelines, Airline requirements, departure country requirements and minimum stay requirement (14 days) of Lotus Villa.

- **PCR tests – If vaccinated** and stay only for 14 days – 02 PCR tests. (On arrival PCR & Exit PCR)

- If vaccinated and stay more than 14 days – 02 PCR tests. (On arrival PCR & exit PCR)
- **If not vaccinated** and stay only for 14 days – 02 PCR tests. (On arrival PCR & exit PCR)
- If not vaccinated and stay more than 14 days – 03 PCR tests. (On arrival PCR, between 12-14 days & exit PCR)
- If your final dose of the vaccination process completed before 02 weeks of the arrival date to Sri Lanka, you will be considered as vaccinated guest.
- PCR test charges – **Euro 35.00 per test**
- No PCR test required for Children below 02 years.
- Children between 02 – 12 years.
If not vaccinated, 02 PCR tests (Day 07 and Exit)
If vaccinated, 02 PCR tests (On arrival and Exit)
- Children between 12 – 18 years.
02 PCR tests (On arrival and Exit)

Step 05 – Settle final stay invoice, PCR & Insurance coverage invoice before the arrival to Lotus Villa.

Step 06 – Please obtain **negative PCR report (English) within 72 hours** before the flight.

Step 07 – Re-check relevant documents prior to boarding to the flight and at the airport checking. Kindly complete Health Declaration Form and keep with you.

Prior to Boarding:

1. Have a valid tourist VISA.
2. Have negative PCR report (English) taken within 72 hours before the flight.
3. Valid passport and return Air ticket.

At the Airport Checking:

1. Negative Covid 19 PCR test report (English) taken within 72 hours before the flight.
2. If fully vaccinated, original copy of the vaccination certificate. (English)
3. Completed Health Declaration Form.
